The Organisation

The Sports Federation of Queensland, trading as QSport, is the representative body for organised, affiliated sport in Queensland and by dint of its extensive membership of mainly State sporting organisations representative of their sporting activity throughout Queensland, is accepted by government as the industry peak body for sport in the State.

Established formally in 1992, the Federation is incorporated as an independent industry based collective.

Its mission is to enhance the development of sport in Queensland by working to promote and sustain interest in the development of organised sport in the State by:

- providing members with forums for the exchange of information, advice and assistance, where appropriate
- formulating policies on any subject pertaining to sport by the collection and collation of the views of members and presenting both the majority and minority view to any other organisation, institution or body governmental, semi-governmental or otherwise as appropriate
- assisting in the coordination of broad, long term planning for sport in the State
- assisting in the coordination of optimum use of sports facilities and other sporting resources in the State
- seeking and identifying direct or indirect funding sources which could be made available for the development of sport in the State, aiming to ensure that these funds are put to their most effective use
- promoting its role and that of sport by, amongst other things, the establishment and presentation of awards of merit or any similar form of recognition for skill, service and ability

QSport is analogous to the Sports Federations of other Australian States and Territories which collectively form the Australian State Sports Federations Alliance (ASSFA).

Chairman's Report

I am pleased again to present the 2010 annual report to members and associated stakeholders.

2010 was my fifth year as Chairman of QSport, a role that continued to provide a great deal of activity, interest and satisfaction.

Much of that was due to the varied nature of sport and the continued good work of the QSport Office but it would be remiss of me not to acknowledge the contribution of the State Minister for Sport in the Hon. Phil Reeves MP whose efforts to enhance sport and assist QSport in that role in his first full year in office were significant factors.

After the high point of December 2009's Sport Awards Presentation attended by 1,200 celebrating sport's contribution to the Q150 celebrations and the new Queensland Sport Hall of Fame, the calendar year 2010 offered QSport a somewhat different agenda, with the outcomes of the Minister's Review of State Government Programs of Assistance to Sport and Recreation and, to a lesser extent, the Crawford led Review of Australian Sport likely impactors on the work program of the State's industry based collective for sport.

Not surprisingly, the first of the two provided the more relevant and engaging scenario for QSport members, particularly the Board and our Chief Executive Officer Peter Cummiskey who, despite some unexpected turnover in the QSport Office, assisted me and the Board to maintain both our engagement and focus with Minister Reeves and his staff on the rollout of the revised suite of programs arising from his review in 2009.

The Minister's decision to establish the Local Sport and Recreation Jobs Plan and create over 2010-2013 hundreds of coordinator positions to assist clusters of sporting clubs

has far reaching implications for sport delivery performance. The remodelling of assistance to State sporting organisations and industry peak bodies like QSport also is significant and whilst the recent natural disasters meant suspension of some assistance to QSport, the overriding outcome of 2010 was a further engaged State Government / industry relationship and a resultant further enhanced role for QSport on behalf of its members and sport in general.

For that, I thank the Minister and his staff and by extension, the Premier and her Cabinet for maintaining support for sport in the more difficult times for Queensland post the global financial crisis and now the challenging times ahead as the Government works to restore those parts of Queensland impacted on, including many sporting bodies, by the recent spate of natural disasters. In these circumstances, sport has an important role to play and its ability to do so is enhanced by an engaged government.

In looking back over the year, the Annual General Meeting in March saw the departure of former Gymnastics Queensland Executive Director Wayne Hill and his replacement by Table Tennis Queensland Executive Officer Derek Scott whose interest in things constitutional led to further minor refinement of the QSport Constitution later in the year.

The Board continued to have a useful blend of several longstanding members and other relatively new faces and as such, has seen no great need to change the way in which Directors come and go from the Board, a Board that was pleased to receive a very positive "report card" from State Government auditors who reviewed and assessed the performance of the Board and staff against funded outcomes and deliverables.

This process laid a solid platform for the Board's

review of its strategic plan when invited by the State Government mid year to make submission for 2011-2013 funding as the industry peak body for sport in Queensland and later in the year, for the proposed new Sport Advisory Service.

That both submissions were successful is testament to the past work and perceived further potential of our organisation.

It would be remiss of me not to acknowledge the pivotal role our CEO plays in the scheme of things alluded to above and on behalf of the Board and the other QSport members, commend him for the QSport Office's ability to keep delivering, acknowledging the loss of his experienced offsider of some years in early 2010 in Operations Manager Belinda Stark placed additional pressure on the QSport secretariat at a time when State and Federal Government engagement increased substantially.

That he was able to maintain core support, including increased sponsorship, and produce a better than budgeted surplus is noteworthy but sets the Board an increasingly important task to ensure our lean secretariat is adequately supported as workload expands.

As with all plans and programs, not everything went according to plan. The Community Sport Protocol with Clubs Queensland and the Local Government Association of Queensland is an area that suffered to some degree from staff turnover and increased demands while information distribution and the Sport Awards will consume some further consideration in 2011.

Board members met on eight occasions during the year, including three times with Minister Reeves, and the Board faces a similar schedule in 2011 as the next State election looms closer.

To the State Government and other major sponsors in The Courier-Mail and Channel 7, thanks for your support in 2010. A particular mention for increased support goes to Seven's Max Walters and new sponsors in QSport auditor PKF Chartered Accountants and Audi Centre Brisbane.

To all our other sponsors and supporters, I express our appreciation and to our members, thanks for your interest and support for what we do on our collective behalf.

To my colleagues on the Board, thanks for your cooperation and efforts as Directors, with special mentions to Deputy Chair Kate Eggar and our Treasurer in 2010 Sport Administrator of the Year John Brennan who once again has stewarded a positive financial result.

Finally, to the QSport staff, thanks for your contribution and efforts to assist me, the other Board members, the broader QSport membership generally and those we deal with in our role of assisting the development of sports in our great State.

CEO's Report

Once again, it is a pleasure to provide members and supporters with my perspective on another year for the State's sports collective.

2010 proved to be both significant and challenging for me in the role I have occupied now since the late 1990's. It was significant because QSport built upon the expanded interface with the State Government created by the Minister for Sport the Hon. Phil Reeves MP and challenging because increased demands associated with more interface with State and Federal Governments coincided with some unexpected turnover in the small, lean secretariat that is the QSport Office.

The departure of longstanding Operations Manager Belinda Stark in February saw first Samantha Dunn and then in September, Kylie Thomson take up in the pivotal coordinator role, with the position unoccupied for a total of close to three months between February and September.

Whilst the Sport Awards attendance of 760 in December, including ten new Hall of Fame inductees / representatives, didn't cause quite the same demands as the previous year's 1,200 strong Q150 celebration, the workloads in just about every other aspect of the overall 2010 program did, with an underdone at times staffing complement having its hands well and truly full.

That said, all the key activities required by the 2010 program occurred with positive feedback albeit a small number of pursuits were curtailed, most notably work in the second half of the year on advancing the Community Sport Protocol with partners Clubs Queensland and the Local Government Association of Queensland.

In last year's corresponding report, I commented on activities related to QSport objectives and will do so again here in relation to 2010.

Again, the QSport Board signed off on the plan and program and an operating surplus that was significantly surpassed, for reasons covered more extensively in the Treasurer's Report, along with maintenance of membership and sponsorship support.

The program required continuation of the opportunities by way of forums for members for the exchange of information, advice and assistance, where appropriate.

Three rounds of Sport Group meetings, a Directors and Officers Information Session, a State Administrators Workshop and three General Meetings were held along with the annual OAMPS Ministerial Breakfast and the Sport Awards Presentation, the latter two providing for informal as opposed to formal networking opportunity.

The formulation of policy by QSport continued into the outcomes of both the Review of State Government Programs of Assistance for Sport and Recreation by Minister Reeves announced in February and the Federal Government response to the Crawford led Review of Australian Sport in May.

Additional involvement on the assessment panel for submissions under the Local Sport and Recreation Jobs Plan became reality for me in the second half of 2010, as did increased dialogue with the Australian Sports Commission in my role as coordinator of the Australian State Sports Federations Alliance (ASSFA).

Involvement in the coordination of longer term planning for sport is an expected outcome of both the above interfaces, as with local government via the Community Sport Protocol.

Minister Reeves' midterm update on progress by the Government in pursuit of aspects of the 2009 State Election QSport Policy Platform

was received in September, noting some are a work in progress.

QSport's ability to identify and secure new funding sources was demonstrated again in December with Minister Reeves' decision to award funding additional to QSport's 2011-13 Industry Peak Body funding allocation for the establishment of the new Sport Advisory Service, noting subsequent suspension of such additional funding in the wake of the recent natural disaster impacts.

Finally, the promotion of sport continued apace, with continued major level support from The Courier-Mail, Channel 7 and the State Government for the annual Sport Awards, incorporating the Queensland Sport Hall of Fame.

My personal thanks go to Minister Reeves, his Policy Adviser Steven Gay and Robert Moore and Department of Communities' Sport and Recreation Services' staff, The Courier-Mail's David Fagan, Brian Burke, Samantha Clark and Paul Malone, Channel 7's Max Walters, Pat Welsh and Craig Dyer, and along with other sponsors and supporters, new Awards program supporters in PKF's John Keating and Audi Centre Brisbane principal Greg Willims – not forgetting XXXX for their hosting of our annual Sponsors function and our longest standing sponsor in OAMPS Insurance Brokers for their support of our Ministerial Breakfast and State Administrators Workshop.

Thanks also to Bob O'Keefe and Shaun Mitchell at the Brisbane Convention and Exhibition Centre for their support of our formal functions

and to Col Smith and Marie Loneragan at our "home" at Sports House, Milton in Brisbane for their assistance during the year.

To all who worked on the Awards, particularly our volunteers in Alyssa Kerr, Jacque Hodgson, Peter Ledwidge and Lauren Knaggs, thanks also for your contribution – we couldn't do it without you!

To the Board, thanks for your input and support, particularly the Chair Richard Griffiths, Deputy Kate Eggar and the Treasurer John Brennan. To other members and supporters, thanks also for your support and hospitality which is most appreciated.

Finally, to the QSport staff over the year, my sincere thanks – to the longstanding Belinda Stark who departed in February, her replacements in first Samantha Dunn and now Kylie Thomson, and our Administration Officer Karissa Petersen – for your efforts supporting me and the organisation.

In conclusion, 2011 has opened with difficulty for many in Queensland, difficulty that hopefully they, with sport as but one important salve, can overcome to return to being optimistic about a place where, despite what nature serves up from time to time, most will want to continue to live.

Board

The Board met with the State Minister for Sport, the Hon. Phil Reeves MP on three occasions covering a number of topics including Commonwealth and State Reviews of Sport outcomes, Common Funding / Service Agreements for NGO's and new programs in the Local Sport and Recreation Jobs Plan and the Sport and Recreation Advisory Service.

As a follow on from the above, the QSport Chief Executive Officer met with the Minister, his Policy Advisors and senior Department Staff on progression of the above.

The Board considered progress on actions agreed at its 2009 Review & Planning meeting and agreed on further minor changes to the Federation Constitution, agreed at the December General Meeting.

The QSport Executive met on one occasion while the Board's June meeting considered the QSport Strategic Plan for 2011-2013.

The Board also determined finalists and winners in several of the Queensland Sport Award categories for 2010.

Summaries of outcomes of Board meetings were prepared and distributed to QSport members.

At year's end, the Board remained satisfied that core objects of QSport were being met, to the extent that resources available reasonably allowed, by QSport's plan and program and would continue to into the foreseeable future.

Member Services

MEMBER MEETINGS

In terms of member meetings convened during 2010, a total of four General Meetings including the Annual General Meeting was held, with attendance as follows:

Full Member State sporting organisations met on three occasions in their Sport Groups during the year in association with General Meetings.

Issues covered at member meetings during 2010 included Advocacy, Federal Government Funding, Hall of Fame, Local Jobs Plan, Member Evaluation Survey, Meeting and Function Schedules, QSport Strategic Plan, Sport and Recreation Advisory Service, Sport Awards, Sport for Disabled, Sporting Organisations Award.

MEMBER INFORMATION SESSIONS

QSport's Directors Information Session held at Sports House, Milton on Monday evening, 15 November, 2010 was attended by 27 representatives from 11 QSport member organisations and 1 representative from a non-member organisation (by invitation).

The aim of the Information Session was to provide members of the Boards/Management Committees of QSport member bodies with information on the Queensland sport sector, government assistance available to sports

and their roles and responsibilities as Board/Management Committee members.

Timing of the session was determined as a result of last year's evaluation survey received from participating members, indicating after hours as the preferred time.

The program concluded with a panel discussion which was undertaken involving all speakers.

Evaluation surveys were completed by participants, with the average rating for the session 8.1 out of a possible 10.

Overall, respondents indicated that presenters were professional and informative and the session was well organised and valuable.

OAMPS STATE ADMINISTRATORS WORKSHOP

QSport conducted a half day State Administrators' Workshop in 2010 at the Brisbane Convention and Exhibition Centre on Wednesday 13 October. A total of 17 representatives from 15 member organisations attended the workshop.

Representation and Policy

QSport's role as the representative body for organised, affiliated sport in Queensland was maintained in 2010.

QSport maintained liaison with the State Government and other parties during 2010 with the QSport Board meeting on three occasions with the State Minister for Sport, the Hon. Phil Reeves MP.

QSport's Chief Executive Officer met with Minister Reeves, his Policy Advisors and senior Departmental staff regularly in what amounted to a continuing strong working relationship between QSport and the State.

QSport maintained representation on various industry and government committees in 2010 including:

- Queensland Fitness, Sport and Recreation Skills Alliance Management Committee
- State Government Healthy Food and Drink Guidelines for Sporting Clubs Reference Group
- State Government Local Sport & Recreation Jobs Plan Assessment Panel
- State Government Sport and Recreation Volunteer Reference Group

Liaison was also maintained with other State and Territory Sports Federations, with QSport's Chief Executive Officer attending meetings in Sydney and on the Gold Coast of the Australian State Sports Federations Alliance (ASSFA), which is comprised of members' CEO's/ Executive Directors/ Officers, with the QSport Chief Executive Officer performing the role of coordinator.

The QSport Chief Executive Officer attended an Australian Sport Commission convened meeting in Melbourne in May on the response to the Federal Government's Crawford Report on Australian Sport and also a number of meetings of Queensland NGO's serviced by the State Department of Communities.

In September, the QSport Chief Executive officer met members of a Chinese State Sports Delegation visiting Queensland on a study tour about sport's structure and servicing.

Promotion

A number of activities which advanced the role of QSport and sport generally were undertaken in 2010, including the following:

OAMPS MINISTERIAL BREAKFAST

Minister for Sport, the Hon. Phil Reeves MP was the guest speaker at the 2010 OAMPS Insurance Brokers sponsored Ministerial Breakfast held on Wednesday morning, 13 October at the Brisbane Convention and Exhibition Centre, with 110 QSport members, sponsors and other supporters present.

The focal point of the Minister's address was the launch of the guidelines for sporting clubs on healthy food and drink options for club canteens. He also touched on the Queensland Government's renewed sponsorship of Sport Award categories and the Queensland Sport Hall of Fame.

OAMPS Regional Manager (Northern) Scott Denning welcomed attendees while the QSport Chief Executive Officer interviewed Queensland and Australian Olympian Beach Volleyball player Natalie Cook about her proposed comeback for the 2012 Olympic Games following the Minister's address.

QUEENSLAND SPORT AWARDS

The third recipient was John Keppie who has made a profound contribution to the sport of Swimming over many years, both as an Administrator and as a Technical Officer. He devotes a huge amount of time to the sport and has achieved a level of excellence that sets him apart from his peers.

John was named Queensland Sport Officiator of the Year in 2001 and 2003.

John has served on the board of Swimming Queensland since 1988, was elected President of the Association in 2008 and received a Medal in the Order of Australia in that same year.

The fourth recipient was Table Tennis stalwart Mick McShane. Mick has volunteered within the sport of table tennis for over 40 years. He has served as an administrator, involved with the Board of Management of Queensland Table Tennis Association for 16 years and his local Brisbane Table Tennis Association for 18 years. For eight years, he was also the President of Queensland Table Tennis Association.

He is best known within the sport as the most successful umpire in Australian Table Tennis history where he has umpired at Paralympic Games, Commonwealth Games, World & Commonwealth Championships; National & State Championships.

In 2008 Mick was selected to umpire at the Beijing Olympic Games, the pinnacle of his glittering career.

The fifth and final Service to Sport Award recipient was from Maryborough in Softball's Barbara Morris who became involved in the administration of Softball when she established the Incas Softball Club 43 years ago, where she remains President to this day.

In 1969 Barbara was the first girl from Maryborough to be selected in a Queensland Team and has held a range of positions on the Board of Maryborough Softball Association for over 30 years and has been involved in distance walking for about 18 years.

Barbara has been awarded life membership at Incas Softball Club and Maryborough Softball Association and has received Service Awards from Softball Queensland and Softball Australia.

Treasurer's Report

It is my pleasure to provide this report on the financial affairs of QSport for the calendar year 2010.

As in previous years that I have been Treasurer, I commend the efforts of the QSport Office staff who are responsible day to day for raising, recording and reporting finances for me, my colleagues on the Board and ultimately the QSport membership.

Early in the year, the organisation lost the services of its Operations Manager Belinda Stark, who secured employment close to her home on the Gold Coast after a number of years excellent service in her role with QSport. Her work in presenting monthly statements and reports and monitoring our accounts and financial transactions was most appreciated by me and also our Chief Executive Officer Peter Cummiskey and Administration Officer Karissa Petersen on whom the bulk of financial issues fell in the intervening months before the arrival of Kylie Thomson as Operations Coordinator late in the year.

In saying that, I also acknowledge the short, four months' contribution of Samantha Dunn in the intervening period in aspects of that role, a role that is vital in the proper maintenance of QSport's financial affairs.

The overall result was a better than expected surplus of \$46,381 which was due largely to State Government support and other sponsorship being increased over 2009 levels (the latter allowing for a one-off contra advertising contribution from The Courier-Mail towards the Queensland Sport Hall of Fame's establishment) and all major expenditure categories coming in not only under budget but also the previous year's figures.

Whilst Sport Awards expenditure was down due to lower than anticipated attendance (as was associated revenue), lower costs in Administration, Functions Other Than Awards and Staffing were the big contributors to the better than budgeted result, particularly as there was no discernable decrease in the performance of the organisation.

At year's end, QSport remained in a sound financial position with all required provisions addressed, over \$300,000 in retained member funds and a commitment from the State Government for extension of our contract for services into 2011-2013 for \$275,000 per annum.

I commend the Balance Sheet and Financial Statements to members for perusal and acceptance.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31 DECEMBER 2010

1. INTRODUCTION

Sports Federation of Queensland is an association incorporated as an industry based collective. The financial statements of Sports Federation of Queensland are for the period 1 January to 31 December 2010.

Principal Activities

The principal activity of the association during the year was the operation as the primary representative body for organised and affiliated sport in Queensland working to enhance and develop sport in Queensland.

Currency

The financial report is presented in Australian dollars and amounts are rounded to the nearest dollar.

Registered Office

The registered office of Sports Federation of Queensland is situated at Sports House, Cnr Castlemaine & Caxton Streets, Brisbane, Queensland 4064.

Authorisation of Financial Report

The financial report was authorised for issue on the 28th day of February, 2011 by the Management Committee.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The Association is not a reporting entity because in the opinion of the management committee it is unlikely that users exist who are unable to command the preparation of reports tailored so as to satisfy all of their information needs. These financial statements are therefore "Special Purpose Financial Reports" that have been prepared solely to meet the accountability requirements under the Association's constitution and the requirements under the Associations Incorporation Act of Queensland 1981.

Accounting standards do not have mandatory applicability and consequently have not been applied.

(a) Revenue Recognition

Sponsorship income is recognised upon invoicing of the sponsor in accordance with the terms and conditions of sponsorship. Adjustments are made to this revenue item when the sponsor's invoice is received.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (cont'd)

(b) Government Grants

Government grants, (including non-monetary grants at fair value) are not recognised until there is reasonable assurance that all conditions will be complied with and that the grants will be received.

Grants are recognised in the income statement over the periods necessary to match them with the related costs which they are intended to compensate, on a systematic basis.

(c) Receivables

Trade accounts receivable and other receivables represent the principal amounts due at balance date less any provision for doubtful accounts.

(d) Income Tax

The Association is exempt from income tax under the Income Tax Assessment Act.

(e) Property, Plant and Equipment

All property, plant and equipment are stated at cost.

Plant and equipment is stated in the financial statements at cost. All plant and equipment are depreciated over their estimated useful lives using the straight line method starting from the time the assets are held ready for use. The average depreciation rates per class of asset are as follows:

(f) Employee Benefits

Wages and Salaries, and Annual Leave

Liabilities for wages and salaries and annual leave are recognised, and are measured as the amount unpaid at the reporting date at current pay rates in respect of employees' service up to that date.

Long Service Leave

The provision is measured at the present value of the estimated future cashflows in respect to services provided up to balance date.
