The Sports Federation of Queensland, trading as QSport, is the representative body for organised, affiliated sport in Queensland and by dint of its extensive membership of mainly State sporting organisations representative of their sporting activity throughout Queensland, is accepted by government as the industry peak body for sport in the State.

Established formally in 1992, the Federation is incorporated as an independent industry based collective

Its mission is to enhance the development of sport in Queensland by working to promote and sustain interest in the development of organised sport in the State by:

- providing members with forums for the exchange of information, advice and assistance, where appropriate
- formulating policies on any subject pertaining to sport by the collection and collation of the views of members and presenting both the majority and minority view to any other organisation, institution or body governmental, semi-governmental or otherwise as appropriate

- assisting in the coordination of broad, long term planning for sport in the State
- assisting in the coordination of optimum use of sports facilities and other sporting resources in the State
- seeking and identifying direct or indirect funding sources which could be made available for the development of sport in the State, aiming to ensure that these funds are put to their most effective use
- promoting its role and that of sport by, amongst other things, the establishment and presentation of awards of merit or any similar form of recognition for skill, service and ability

OSport is analogous to the Sports Federations of other Australian States and Territories which collectively form the Australian State Sports Federations Alliance (ASSFA).

Chair's Report

It is my privilege to present this report to QSport members and other interested parties on the activities of the State's industry based sports collective for the 2011 calendar year.

I do so due to the resignation, effective days before Christmas 2011, of the QSport Chair of the past five years in Richard Griffiths, the AFL Queensland CEO who has moved to the AFL's Greater Western Sydney franchise after 15 years based in Brisbane steering the administration and development of the participation level program for the AFL in Queensland.

Aided by resources that are envied by all other sports, Richard has done a sterling job in boosting his code in that time and similarly providing leadership for the OSport Board as it has progressed these past five years.

The Board thanks Richard Griffiths for his contribution to OSport and wishes him well in his new role.

2011 was a challenging year for QSport, with natural disasters dominating the first quarter and impacting on the organisation in more ways than one.

While the immediate impact of the flooding of parts of Brisbane in January was the closure of the QSport Office adjacent to Suncorp Stadium for a week, the flow on effect saw many QSport member bodies' activities for months afterwards skewed towards restoring their flood affected clubs' facilities, with the help of governments, aid agencies, businesses and a gratifyingly large army of volunteers from all walks of life pitching in to help fellow Queenslanders.

For its part, QSport organised discussion between Minister for Sport Phil Reeves, his officers and counterparts from Brisbane and Ipswich City Councils with affected State sporting bodies on impacts and assistance required and QSport CEO Peter Cummiskey accompanied the Minister on a number of visits to regional localities to inspect flood damaged sporting facilities.

OSport also offered up previously approved funding totalling over \$200,000 to the Ministers' Flood Fightback Fund to assist sport and recreation bodies restore facilities

That said, sport then played an influential role in raising the spirits of many disaster affected Queenslanders, with morale boosting victories by the likes of the Brisbane Roar, the Queensland Firebirds, the Queensland Reds and the Queensland Maroons giving all Queenslanders something to cheer about after such a tough opening to the year.

And at year's end, OSport's organisation and delivery of a memorable Sport Awards Presentation in November which featured the elevation of 11 outstanding Queensland sporting heroes as the 1st XI Legends in the Queensland Sport Hall of Fame, aided by our partners in News Queensland, Channel 7 and the State Government, topped it all off nicely for sport here in 2011.

All the above stretched the OSport Office of three at times and for only the second time in 15 years, the organisation recorded an operating deficit, sanctioned by the Board in August and associated in part with the one-off costs of assembling the Hall of Fame Legends for elevation at the Sport Awards Presentation, a cost OSport was happy to meet, endorsed by the response to their presence at this event which again was the biggest of its type across the country.

During the year, there was minimal change

to the faces around the QSport Board table, with consensus the aim and support for our members via our hardworking staff the order of the day.

There was considerable dialogue with our principal funding agent in the State Government via the Minister for Sport who met the Board on four occasions.

OSport places on record its appreciation of Minister Reeves' consultative approach and commends him and the Bligh Government on their support of sport in this State.

From mid year, with a State election due in the first half of 2012, discussion broadened to include meetings with the Opposition via Shadow Minister for Sport David Gibson and by Christmas, both major political parties had been furnished with QSport's 2012 State Election Policy Platform outlining those activities/ issues QSport believes need commitment to by the Government elected at the impending election.

OSport's credibility and effectiveness as the advocate for organised sport owes much to its performance, performance that from time to time needs to be assessed by those it aims to serve.

With that in mind, OSport again submitted to evaluation by members conducted externally via email of its activities.

The outcome proved that OSport continues to be perceived as an effective voice for sport, constrained only by resources available with which to prosecute sport's case.

As a tool to argue for further support in 2012 and beyond, one of the QSport Board's final decisions for 2011 approved the commissioning of QSport auditor, business advisor and sponsor PKF to research and report on the value of sport to Queensland, with particular attention to be paid to its quantitative contribution to the State economy.

OSport, through its CEO's coordination of the Australian State Sports Federations Alliance, continued to input on behalf of State and community based sport to national advocacy arrangements in what is an increasingly demanding role.

Finally, it needs to be said again that OSport could not operate as it does without the significant support of the State Government, both as principal funder and sponsor, along with a loyal band of other longstanding supporters for the Sport Awards and other activities.

Likewise, without staff to carry out the organisation's program, we would not exist as well as we do and on behalf of the Board, I acknowledge the QSport Office for its efforts.

Last but no means least are our members. Without your support, the notion of a sports collective is just that and the Board and staff thank you for your efforts in the demanding year for you all that was 2011.

CEO's Report

2011 provided OSport with a number of opportunities to prove its relevance to its members, sponsors and other supporters.

In a year in which sport played a meaningful role in lifting a Queensland confronted by its toughest year for quite a while, QSport was involved with both the low and high spots in a year with a difference.

From being forced out of the QSport Office adjacent to Suncorp Stadium for a week by the flooded Brisbane River in January to producing one of the best celebrations of our very best sporting achievers in November, I saw QSport play a positive role for Queensland and Queenslanders.

And more significantly on a wider front, I saw many QSport member body State sporting organisations and their constituent clubs and a number of QSport Associate members pitch in with everything from personal and financial contribution for disaster affected fellow Queenslanders to scintillating on field performances that, from time to time, lifted our individual and collective spirits.

That said, much of the year was about the type of things that QSport does from one year to the next to assist member bodies maintain their momentum in the ongoing development of their sports and associated activities.

There were things that were different, though, including more emphasis on member networking and, for me, greater involvement in government program delivery via membership of the Local Sport and Recreation Jobs Plan Assessment Panel and from mid year, the Stadiums Queensland Board of Directors.

In reviewing the year, one recurring thought is how much more is passing before my eyes and through the QSport Office, most via email. Another is the expectations of others of OSport these days compared with not so long ago, including by government as OSport's single biggest financial contributor.

There is no doubt that collaboration with government has increased, as have reporting requirements, scrutiny and intervention in some of the processes that surround decision making on funding and services for the sector.

OSport's 2012 State Election Sport Policy Platform, developed over the second half of 2011 and after discussion with both the State Minister for Sport Phil Reeves and his Opposition counterpart David Gibson, will become the vehicle for pursuing change with whichever party wins the election.

While OSport is a State based industry collective, once again in 2011 it found itself drawn into discussion at national level in the sector and as coordinator of the Australian State Sports Federations Alliance (ASSFA) and in conjunction with other State/ Territory Sports Federations, OSport continued to attempt to deal with impacts on our constituents arising from national level issues.

Earlier on, I alluded to a memorable event in November 2011 that in many ways, made any issues of concern pale into less significance, certainly at least for a few weeks leading into Xmas.

I refer to the 2011 Queensland Sport Awards/ Hall of Fame Presentation on 21 November, held once again in the Brisbane Convention and Exhibition Centre and attended by over 850, including nine of the 1st XI Legends of Queensland Sport elevated from Member to Legend status in the Queensland Sport Hall of Fame.

Flanked by fellow overseas based Roy Emerson

and Greg Norman and surrounded by Australian based greats in Mick Doohan, John Eales, Cathy Freeman, Wally Lewis, Susie O'Neill and Kieren Perkins, Rod Laver and his Legend compatriots proved that super star presence is truly something to behold. The front page picture and story in The Courier-Mail the following day said it all

Thinking about that event reminds me that it would all not be possible without our sponsors and other supporters who make this event the biggest and best of its type across the country.

From major sponsors in News Queensland, Channel 7 and the Queensland Government through to people like our band of young volunteers on the night, QSport is both fortunate and appreciative of how you all help the QSport staff give us a great sporting related event each year to enjoy and remember.

I've mentioned "government" earlier on and it would be remiss of me not to mention specifically the effort of Minister for Sport Phil Reeves in pursuing his sport portfolio responsibilities and particularly his working relationship with the State's industry peak body for organised sport.

His regular consultation over policies and programs and his interface with the QSport Board and members more broadly has marked him as an effective conduit between government and the sector.

For the record, 2011 saw membership, government funding, sponsorship and income overall increase. So, too, did expenditure and so, too, did our presence and program of support for our members, members which

pay very little relatively speaking for what is provided.

At year's end, an externally conducted survey of our members indicated QSport is on the right track, albeit some will always want more.

The year ended also with the resignation of our Chairman of the past five years in Richard Griffiths who opted for a fresh opportunity in his beloved AFL in Greater Western Sydney. I and the other staff want to publicly record here our thanks for his leadership and support. It has been enjoyable working with him and we wish him well into the future.

To the OSport Board, thanks for your assistance and support and your willingness to contribute to the good governance of our organisation. To our membership more broadly, thanks also for your support and your hospitality on occasions when our paths cross at your activities and events.

Finally, to my colleagues in the OSport Office in Kylie Thomson and Karissa Petersen, my appreciation for your efforts in support of me, the Board and those who support us. Best wishes, Karissa, for the next 12 months.

2012 shapes as another challenging year for sport and the wider Queensland community. All things being equal, QSport will be there for the good of us all.

Board

The Board met with the State Minister for Sport, the Hon. Phil Reeves MP on four occasions and also Shadow Minister for Sport David Gibson at its annual Review and Planning meeting in August. The discussions focussed on government policies and programs for sport as part of development of the 2012 State Election Sport Policy Platform.

The Board considered progress on actions agreed at its 2010 Review & Planning meeting.

The Board also determined finalists and winners in several of the Queensland Sport Award categories for 2011.

Summaries of outcomes of Board meetings were prepared and distributed to QSport members.

At year's end, the Board remained satisfied that core objects of QSport were being met, to the extent that resources available reasonably allowed, by OSport's plan and program and would continue to into the foreseeable future.

Ordinary Member State sporting organisations met on three occasions in their Sport Groups during the year in association with General Meetings.

MEMBER INFORMATION SESSIONS

QSport's Directors Information Session held at Sports House, Milton on Tuesday evening, 7 June, 2011 was attended by 17 representatives from 13 QSport member organisations and 1 non member sport.

The aim of the Information Session was to provide members of the Boards/Management Committees of QSport member bodies with information on the Queensland sport sector,

government assistance available to sports and their roles and responsibilities as Board/ Management Committee members.

Timing of the session was determined as a result of last year's evaluation survey received from participating members, indicating after hours as the preferred time.

Topics covered in segments included:

OSport continued to provide advice and information to its members on a one-to-one basis in 2011 and as part of its Industry Peak Body funding agreement with the State Government, provided details on the types of enquiries by category.

Representation and Policy

OSport's role as the representative body for organised, affiliated sport in Queensland was maintained in 2011.

OSport maintained liaison with the State Government and other parties during 2011 with the OSport Board meeting on four occasions with the State Minister for Sport, the Hon. Phil Reeves MP. It met Shadow Minister David Gibson at the Board's annual Review and Planning meeting in August.

OSport's Chief Executive Officer also met with Minister Reeves, his Policy Advisors and senior Departmental staff regularly in what amounted to a continuing strong working relationship between OSport and the State.

OSport maintained representation on various industry and government committees in 2011 including:

The focal point of the Minister's address was the positive contribution that Gold Coast based major facilities like Skilled Park and the new Metricon Stadium and major events like regular AFL & NRL matches make, and a successful bid for the 2018 Commonwealth Games would make to the economic and community development of the Gold Coast.

1st X1 Legends



The 1st XI Legends were installed in the Queensland Sport Hall of Fame on 21 November.

Nine of the eleven "Legends" attended the presentation in person.

The lunch also provided an opportunity to acknowledge the long standing Managing Director of the Queensland Rugby Football League in Ross Livermore.

The Hon. Phil Reeves MP was also present to update members on the latest government initiatives in sport and an opportunity to speak to the Minister personally.

Mark Peters, the CEO of the 2018 Commonwealth Games Bid Team also gave a brief overview of his recent trip to Malaysia and how the Australian bid for the Gold Coast was progressing.

Treasurer's Report

Once again it is my pleasure to provide this report on the financial affairs of QSport for another calendar year.

Again, as in previous years, I commend the QSport staff who handle the day to day work associated with the raising, recording and reporting of finances to me and my fellow Board members and ultimately the wider QSport membership.

Perusal of the financial statements shows an operating deficit of \$19,858 which is the first deficit in 12 years and in line with the Board's expectation following a review in August .

Income, in fact, rose by \$101,098 on the previous year's figure, due mainly to an increased contribution from the State Government via its IPB Funding contract, increased support from members and other supporters for some QSport functions and increased contra sponsorship support from News Queensland, producer of The Courier-Mail, for the Sport Awards/ Hall of Fame.

Expenditure, though, rose by \$167,337 on the 2010 figure, with increases in all cost areas including Administration & Meetings (due mainly to one-off losses on disposal of some office equipment), Functions (largely due to the abovementioned contra advertising support from News Queensland for the Sport Awards/ Hall of Fame and associated one-off travel costs) and Staffing (via a full complement of three staff for the entire year).

With all required provisions addressed, over \$300,000 in retained member funds and a contract from the State Government for some \$570,000 for services to be provided in 2012-13, QSport remains in a sound financial position.

I commend the Balance Sheet and Financial Statements to members for perusal and acceptance.

1. INTRODUCTION

Sports Federation of Queensland ("Association") is an association incorporated as an industry based collective. The financial statements of Sports Federation of Queensland are for the period 1 January to 31 December 2011.

Principal activities

The principal activity of the association during the year was the operation as the primary representative body for organised and affiliated sport in Queensland working to enhance and develop sport in Queensland.

Currency

The financial report is presented in Australian dollars and amounts are rounded to the nearest dollar.

Registered office

The registered office of Sports Federation of Queensland is situated at Sports House, Cnr Castlemaine & Caxton Streets, Brisbane, Queensland 4064.

Authorisation of financial report

The financial report was authorised for issue on the 24th day of February 2012 by the Board of Management.

2. SUMMARY OF ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of the financial statements are set out below. These policies have been consistently applied to all the years presented, unless otherwise stated.

Basis of accounting

The Association is not a reporting entity because in the opinion of the Board of Management it is unlikely that users exist who are unable to command the preparation of reports tailored so as to satisfy all of their information needs. These financial statements are therefore "Special Purpose Financial Reports" that have been prepared solely to meet the accountability requirements under the Association's constitution and the requirements of the Associations Incorporation Act of Queensland 1981.

Accounting standards do not have mandatory applicability and consequently have not been applied.

FOR THE YEAR ENDED 31 DECEMBER 2011

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (cont'd)

(a) Revenue recognition

Sponsorship income is recognised upon invoicing of the sponsor in accordance with the terms and conditions of sponsorship. Adjustments are made to this revenue item when the sponsor's invoice is received.

(b) Government grants

Government grants, (including non-monetary grants at fair value) are not recognised until there is reasonable assurance that all conditions will be complied with and that the grants will be received.

Grants are recognised in the Statement of Comprehensive Income over the periods necessary to match them with the related costs which they are intended to compensate, on a systematic basis.

(c) Receivables

Trade accounts receivable and other receivables represent the principal amounts due at balance date less any provision for doubtful accounts.

(d) Income tax

The Association is exempt from income tax under the Income Tax Assessment Act 1997.

(e) Property, plant and equipment

All property, plant and equipment are stated at cost.

Plant and equipment is stated in the financial statements at cost. All plant and equipment are depreciated over their estimated useful lives using the diminishing value method starting from the time the assets are held ready for use. The average depreciation rates per class of asset are as follows:

Plant and equipment 15% Motor vehicles 22%

(f) Employee benefits

Wages and Salaries, and Annual Leave

Liabilities for wages and salaries and annual leave are recognised, and are measured as the amount unpaid at the reporting date at current pay rates in respect of employees' service up to that date.

Long Service Leave

The provision is measured at the present value of the estimated future cashflows in respect to services provided up to balance date. Liabilities are determined after taking into consideration estimated future increases in wages and salaries and past experience regarding staff departures. Related on costs are included.
